## \$45,000\* Endless Summer Slot Tournament June 9, 2025 Official Rules

The \$45,000\* Endless Summer Slot Tournament ("<u>Tournament</u>") will take place at Fontainebleau Las Vegas, located at 2777 South Las Vegas Blvd., Las Vegas, NV 89109, beginning at 10:30 a.m. through 4:30 p.m. on Monday, June 9, 2025. \*All Tournament prizes will be awarded in the form of Slot Free Credit.

## **Tournament Specific Rules:**

- 1. Participants of the Tournament ("<u>Participants</u>") are limited to invited Fontainebleau Rewards members who are at least 21 years of age with a valid government-issued identification.
- 2. Participants must register for the Tournament in order to participate and receive their Session (defined below) time.
- 3. Registration will take place in Pit 12 on the Casino Floor (the "<u>Tournament Area</u>"), beginning at 10:30 a.m. through 2:00 p.m. on Monday, June 9, 2025.
- 4. The Tournament will take place inside the Tournament Area starting at approximately 12:00 p.m. on Monday, June 9, 2025, and will continue until all Tournament play is complete.
- 5. The Tournament will consist of ten (10) sessions (each, a "Session"), with two (2) three (3)-minute rounds per Session (each, a "Round").
- 6. Participants will be randomly assigned their Session time and Tournament machine.
- 7. Participants must be present at all scheduled times, play at their assigned machine, and report to the Tournament Area ten (10) minutes prior to each Round.
- 8. Failure to report to the scheduled Round time will result in a zero score.
- 9. Only one (1) Participant may play per machine per Round. The scores of each Round become official scores once the assigned machine displays the Participant's score for that Round.
- 10. A Participant's score for each Round is determined by the number of points registered on their assigned Tournament machine at the end of their Round.
- 11. After completion of each Round, each Participant's score will automatically be added to the running score sheet through the Tournament Manager system ("Tournament System").
- 12. By participating in the Tournament, Participants accept all final scores which the Tournament System displays. Any discrepancies with a Participant's score must be brought to the Tournament Management's attention prior to the start of the next Round.
- 13. The Tournament machines will contain internal credit meters that will automatically shut off the machine after the time expires. Tournament machines will be set for "Tournament play" and money or tokens will not be accepted for Tournament play. Participants will play the same assigned Tournament machine during each Round of play.
- 14. It is the Participant's responsibility to immediately notify the Tournament Management of any Tournament machine malfunction during a Round. Upon notification of a malfunction, Tournament Management will determine, at its sole discretion, whether to continue play, to change machines, or to replay the Round. Minor pauses or delays are not considered machine malfunctions.
- 15. Tournament rankings will be determined by the aggregate total scores earned by each Participant during the two (2) Rounds for each Participant.
- 16. In the event of a tie, the prize will be split equally between tied Participants. For example, if two Participants tie for first place, they would equally split the first and second place prizes, and the Participant with the next highest score will receive the third-place prize.
- 17. All Tournament prizes will be awarded in the form of Slot Free Credit. Slot Free Credit prizes will automatically be issued to the winner's Fontainebleau Rewards account and are valid for 72 hours from the date and time of issuance. Slot Free Credit prizes are only valid for use on select Fontainebleau Las Vegas slot machines; certain exclusions apply. Please inquire with the Fontainebleau Rewards Desk for details.
