

Fontainebleau Offer Match Promotion Official Terms & Conditions

Terms and Conditions:

The Fontainebleau Offer Match Promotion ("Promotion") commences on Tuesday, November 25, 2025 and will continue until subsequently cancelled by Fontainebleau Las Vegas ("Fontainebleau") located at 2777 South Las Vegas Blvd., Las Vegas, NV 89109.

Promotion Specific Rules:

1. This Promotion is open to Fontainebleau Rewards members who are at least 21 years of age with a valid government-issued identification ("Participant").
2. To participate in the Promotion, the Participant must have a complete Fontainebleau Rewards account which includes name, birthday, address, phone number, and e-mail address which may be updated at the time of submission to participate.
3. Pursuant to this Promotion, Fontainebleau may honor the qualifying, non-expired rewards club offers (the "Competitor Offer") of competing luxury Las Vegas Strip properties for eligible Participants who otherwise meet the conditions of this Promotion.
